### NOTICE

#### Sub: FSAs with existing State/Govt. Power Utilities under NCDP

Further to Notice No. SECL/BSP/S&M/COMM/150/NCDP/396 dated 10.06.2009 and SECL/BSP/S&M/COMM/150/NCDP/514 dated 18.06.2009 on the above subject, in terms of further directives from CIL, the following points may be noted by all concerned regarding Model FSA :-

1. Regarding balance life of plant/unit to be incorporated in Schedule-I of FSA, Power Utilities are required to submit a self-declaration in the prescribed format appended herewith before or at the time of signing the FSA. The footnote appearing in Schedule-I of Model FSA regarding balance life marked within (\*\*) will stand deleted.
2. In column III of the table under Clause 3.6.1 of Model FSA, the words "at the rate of simple average of Base Price of Grades, as shown in Schedule-II" shall be replaced by the words "at the rate of weighted average Base Price of Grades of Coal received".
3. Under sub-clause c) of clause 2 of Schedule-IV of the model FSA dated 29.05.2009, the words "Weight of each part of such sample shall be minimum 5 kgs" are to be replaced by the words "Weight of each part of such sample shall be about 10 kgs".
