Sub : Submission of commitment guarantee (CG) in terms of decisions of SLC (LT) relating to pre-NCDP LOA cases.

Dear Sir,

This has reference to decisions of SLC(LT) meetings for Power held on 22<sup>nd</sup> and 23<sup>rd</sup> Oct. 2008 (vide Item No. 3) & on 12.11.2008 [(vide Item No. 21(e)] relating to pre-NCDP LOA cases of TPPs/PPs. Further instructions for implementation of above decisions of SLC(LT) have been received from CIL vide letter No. CIL/CMO/SO/47252(New Pol)/444 dtd. 17.4.2009.

In accordance with the aforesaid directives, under item 3(ii) the commissioning period beyond six months shall reckon with the base date of the issuance of the minutes of SLC (LT) meeting dtd. 22 / 23.10.2008 i.e. 27.11.2008.

Prior to this, vide our letter No. SECL/BSP/S&M/COMM/150/NCDP/4371 dtd. 28.2.2009, commissioning status of respective Units including COD was asked. As per the information received from the Units as per enclosed list, these Units have commissioning date including COD beyond 6 months i.e. beyond 26.5.2009.

As such, as per the directives of MOC/CIL referred hereinabove, the Units as per enclosed list are required to submit commitment guarantee (CG) of the required amount within 45 days of issuance of this letter. In terms of item 3(ii) of SLC(LT) meeting dtd. 22/23.10.2008, if commitment guarantee is not furnished within stipulated time, such cases will be reported to SLC(LT) for taking a view on cancellation/deferment of such cases.


The amount of commitment guarantee (CG) in respective cases is indicated against each.
