Sub.: Submission of Security Deposit/Commitment Guarantee for FSA/LOA and current status of FSA/LOA

Further to notices no. SECL/BSP/S&M/COMM/150/NCDP/814 dated 19.03.2008 no. SECL/BSP/S&M/COMM/150/NCDP/855 dated 25.03.08, no. SECL/BSP/S&M/COMM/150/NCDP/863 dated 28.03.2008 and no. SECL/BSP/S&M/COMM/150/NCDP/866 dated 29.03.2008, all existing valid linked consumers of SECL and the consumers to whom LOAs are to be issued by SECL are hereby informed that the **Provisional amounts** of Security Deposit (SD) for FSAs and Commitment Guarantee (CG) for LOAs have been worked out in most of the cases and for the remaining also, the same is under progress.

These amounts as well as current status of FSA/LOA in each case are being placed on SECL website www.secl.gov.in, which will be updated regularly as the process goes on. The same can be viewed on SECL website through the **link** titled **Coal Sales & Customer Satisfaction** and **sub link** titled **Submission of SD/CG and current status of FSA/LOA**. However, the details are provisional and subject to revision, as and when required. All concerned are requested to carefully go through the details and take necessary action accordingly.

In case of FSAs, it is desirable that the Security Deposit (SD) is submitted within 3 days of the amount being displayed on SECL website, so as to complete the signing of FSAs within the deadline of 30.04.2008 and to avoid last minute rush.

As already notified, SD can be submitted either at SECL Bilaspur (in case of cash) or at SECL, Kolkata office (directly through bank in case of BG). Further, the consumers may also exercise the option of depositing at least 50% of the indicated amount before signing the FSA, as per the stipulated provisions under FSA, if they so desire.
